

## VIP-9831A IP Indoor Stealth Horn

### INTRODUCTION

The VIP-9831A IP Stealth Horn is a self-contained paging system which enables voice paging up to 300 feet from an Ethernet connection. The VIP-9831A consists of a horn and Network/Audio Interface board allowing stand alone capability when used with a SIP enabled telephone system or can be accessed from a variety of Valcom managed VoIP products.

## Status Indicator Lights

The VIP-9831A has 2 status indication lights located on network jack:

**Green LED: (Link)** Indicates Ethernet connection when illuminated.

**Yellow LED: (Activity)** Indicator flashes to indicate network activity.

## Operation

Provide paging from SIP connection or via a variety of Valcom managed VoIP products. Integration to customer telephone system can be via SIP registration, FXO port (with VIP-811), or FXS port (with VIP-821).

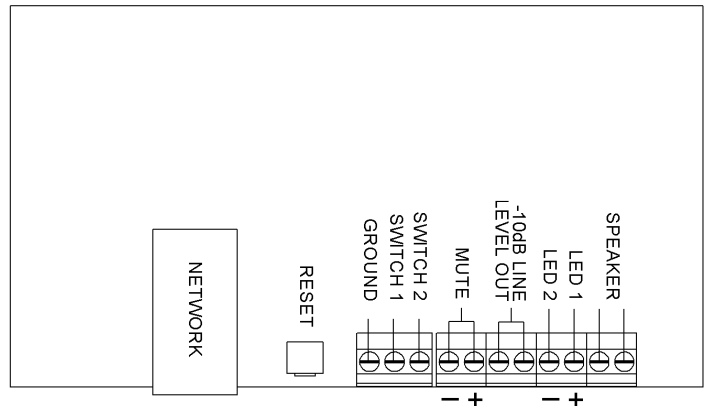


Figure 1. Connections

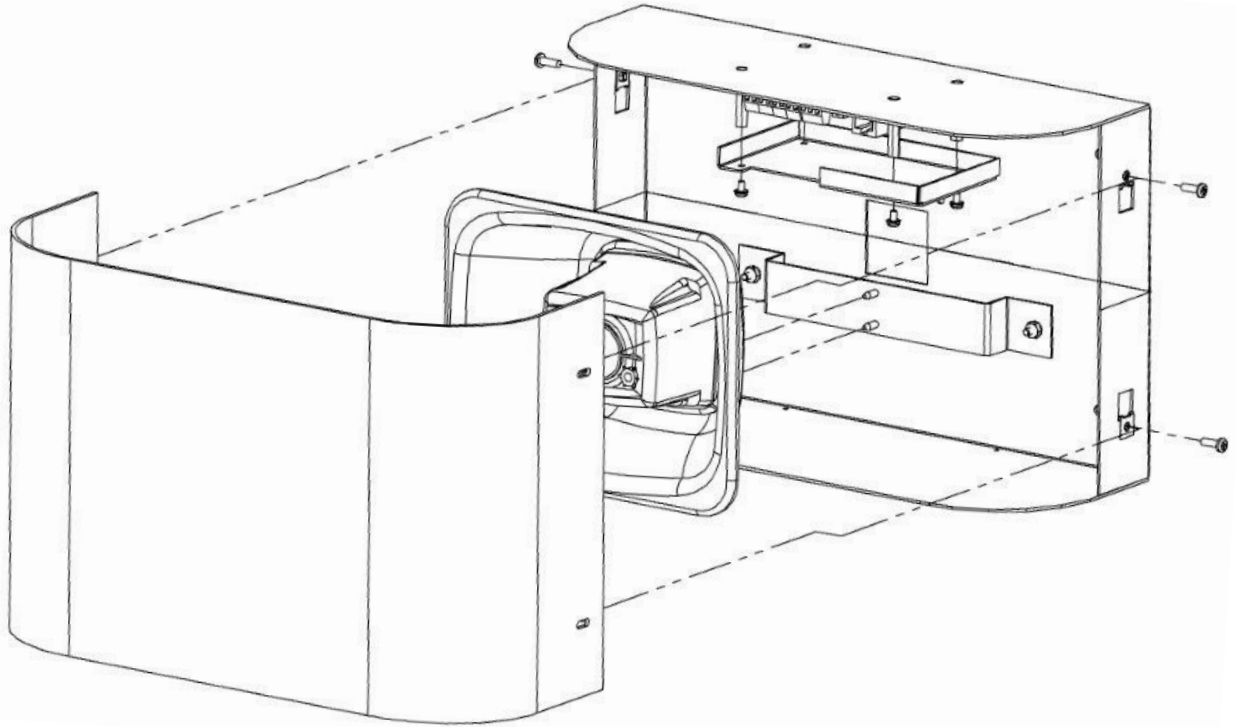
## Mounting (Enclosure / Horn)

The horn should be mounted 8 to 12 feet above the floor to allow for best sound distribution. This unit can be mounted to a single gang, double gang, octagon electrical box or wall. See to Figure 2.

- Using a Phillips screwdriver, remove 4 screws attaching grille to enclosure base.
- Using a 11/32 nut driver, carefully remove horn bracket assembly from enclosure base. Do not remove horn from bracket.
- Carefully disconnect the black and white speaker wires from Network/Audio PC board
- Mount enclosure base to wall using appropriate hardware.
- Reconnect black and white speaker wires to Network/Audio PC board.
- Install horn bracket assembly.
- Connect 802.3af compliant PoE port (300 feet maximum distance) to network connector on Network/Audio PC board.
- Install grille onto enclosure base.

## Setup

Information specific to your application will need to be programmed into the VIP-9831A using a computer. Setup will be done using the IP Solutions Setup Tool.
