

## VIP-428A IP PoE SPEAKER WITH SQUARE FACEPLATE

### INTRODUCTION

The VIP-428A IP PoE Speaker with Square Faceplate enables voice access to a single zone of paging over an IP-based LAN/WAN. This allows a page zone extension anywhere on the network. The enclosure is made of steel with a durable white powder coated finish. The color of the enclosure can easily be changed to match any decor. Power is provided to the Vip-428A via a Power over Ethernet (PoE) switch meeting the 802.3af specification.

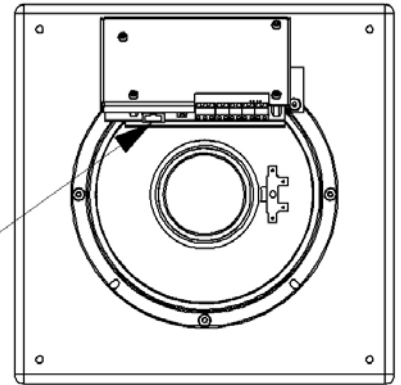

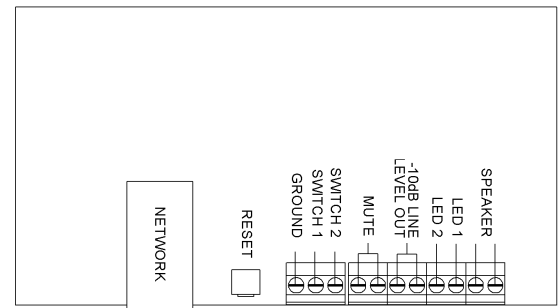

**Network Connection**

The VIP-428A has one RJ-45 network connector on the rear panel. Use a standard patch cable and connect the VIP-428A to an Ethernet switch. (See Figure 1)

**MUTE OUT CONNECTION**

The Mute Out may optionally be connected to the mute input of Valcom Classroom audio management systems in order to suspend locally originated classroom audio during intercom announcements.

**LED Connection**

LED 1 (+) and LED 2 (-) is a current limited output designed to illuminate an optional LED. The LED is intended to provide visual indication of call progress. The LED illumination will flash when the call switch is pressed and will continue to flash until the call is answered. The LED illumination will be solid when a connection to the unit is established

**-10 dB Line Level Out Connection**

The -10dBm Line Level Out may be connected to up to 40 Valcom Self Amplified Speakers in order to provide additional sound reinforcement in an area.

**Call Switch Connection**

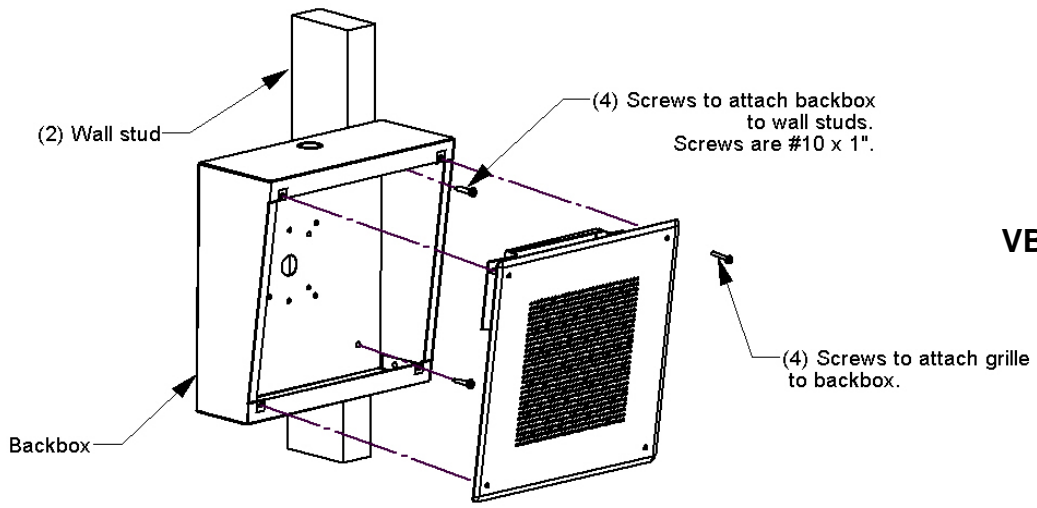
The VIP-428A provides a call switch input via screw terminal connections, labeled Switch 1 and Ground.

**Setup**

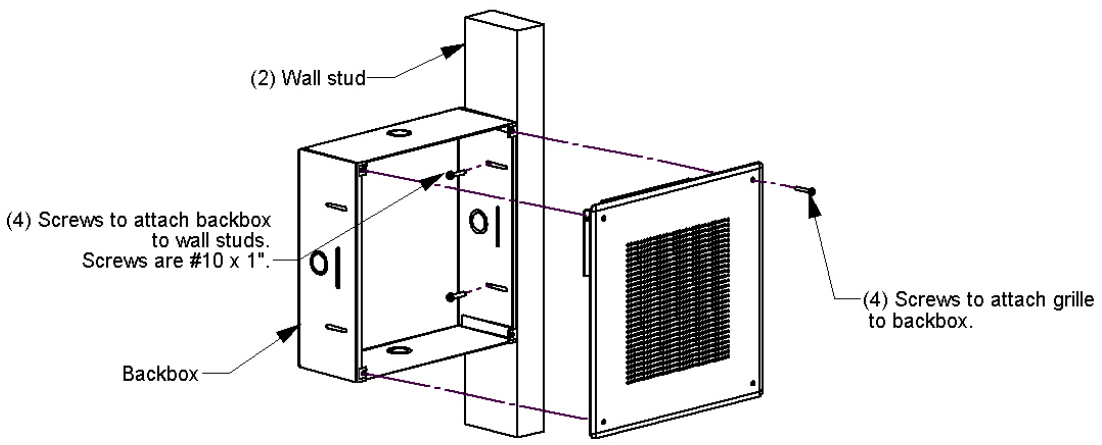
Information specific to your application will need to be programmed into the VIP-428A using a computer. The PC used for programming should be connected to the same subnet as the VIP-428A. **Mounting**

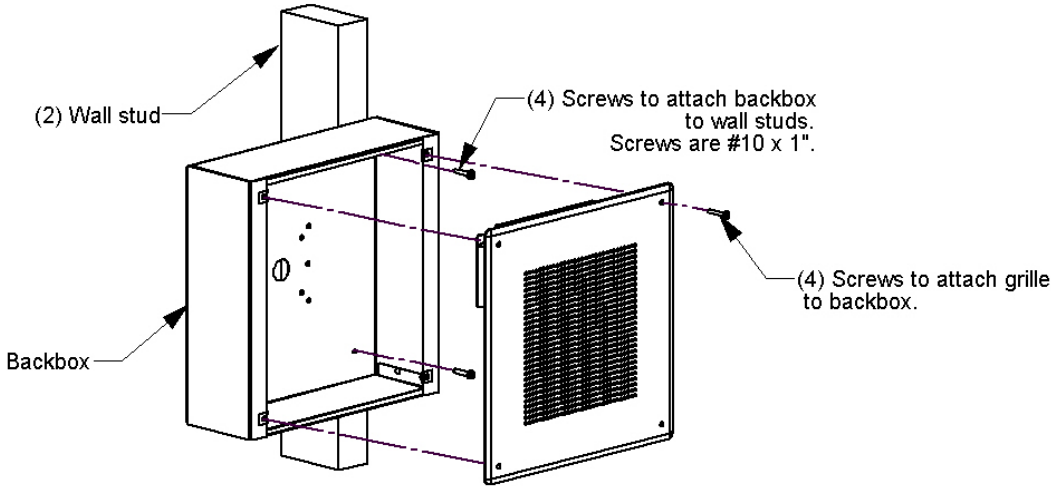
Valcom offers three backboxes (not included) for mounting the VIP-428A speaker. The VB-S11 (surface mount), VB-A13 (angled surface mount) and VB-R12 (recess mount) are all designed to fit the VIP-428A. Mount the backbox according to the instructions provided with the backbox. After mounting the backbox, connect the Ethernet cable to the RJ-45 jack on the speaker. Mount the speaker baffle to the backbox with the hardware provided.
