

## VIP-429A-D IP FLUSH MOUNT SPEAKER/CLOCK ASSEMBLY

### INTRODUCTION

The VIP-429A-D IP Wall Speaker with Clock enables voice access and visual time indication to a single zone of paging over an IP-based LAN/WAN. This allows page zone extension anywhere on the network. The speaker level is adjusted via software during set up. Clock synchronization is initiated via connection to any Network Time Protocol (NTP) server accessible via the network. The enclosure is made of steel with a durable powder coated finish. The color of the enclosure can easily be changed to match any decor. Power is provided to the VIP-429A-D via a Power over Ethernet (PoE) switch meeting the 802.3af specification.

## Assembly and Mounting

Valcom offers three backboxes (not included) for mounting the VIP-429A-D speaker. The VB-R22 (recess mount); VB-S23 (surface mount) and VB-A24 (angled surface mount) are all designed to fit the VIP-429A-D. Mount the backbox according to the instructions provided with the backbox. After mounting the backbox, connect the Ethernet cable to the RJ-45 jack on the speaker. Mount the speaker baffle to the backbox with the hardware provided.

## Mute Out Connection

The Mute Out may optionally be connected to the mute input of Valcom Classroom audio management systems in order to suspend locally originated classroom audio during intercom announcements.

## Network Connection

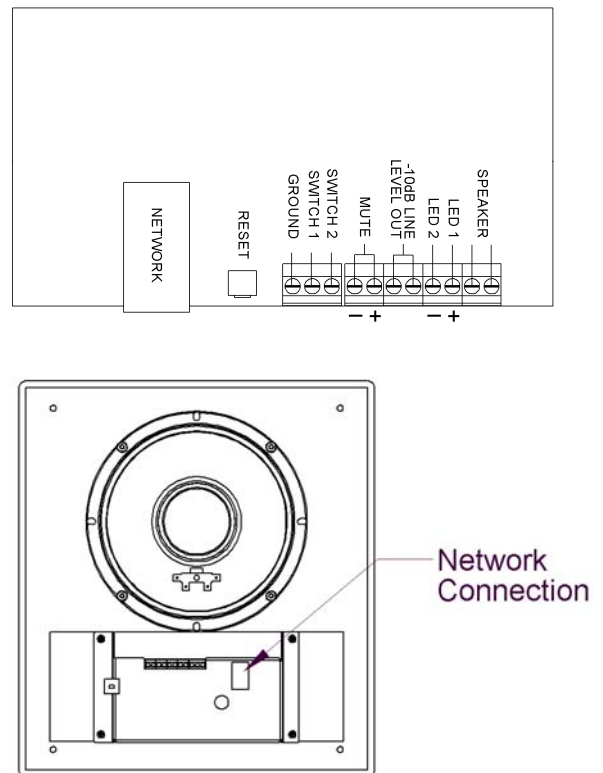


Figure 1. Connections

The VIP-429A-D has one RJ-45 network connector on the rear panel. Use a standard patch cable to connect the VIP-429A-D to an Ethernet switch providing Power over Ethernet (PoE) meeting the 802.3af specification. If the switch does not provide power, a mid-span power injector may be used. (See Figure 1)

## Call Switch Connection

The VIP-429A-D provides a call switch input via screw terminal connections, labeled Switch 1 and Ground.

## LED Connection

LED 1 (+) and LED 2 (-) is a current limited output designed to illuminate an optional LED. The LED is intended to provide visual indication of call progress. The LED illumination will flash when the call switch is pressed and will continue to flash until the call is answered. The LED illumination will be solid when a connection to the unit is established.

## -10 dB Line Level Out Connection

The -10dBm Line Level Out may be connected to up to 40 Valcom Self Amplified Speakers in order to provide additional sound reinforcement in an area.

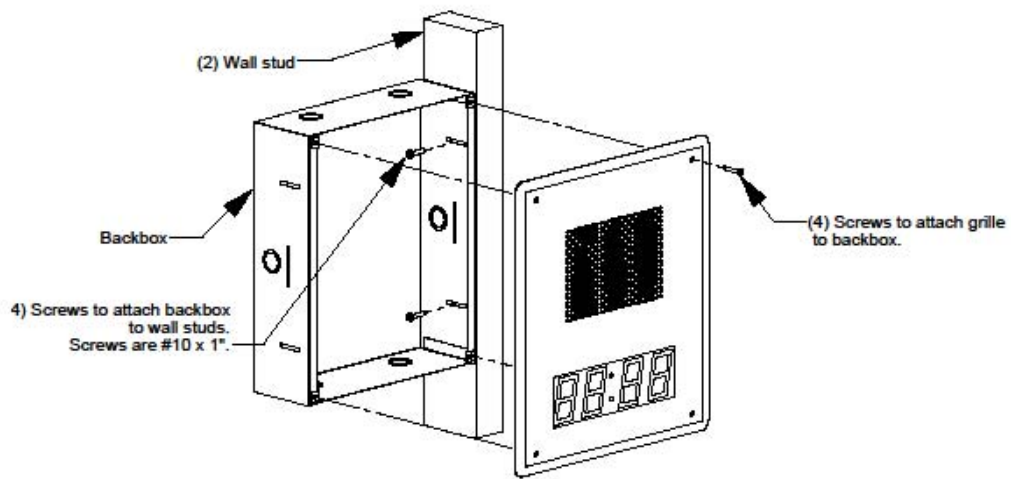

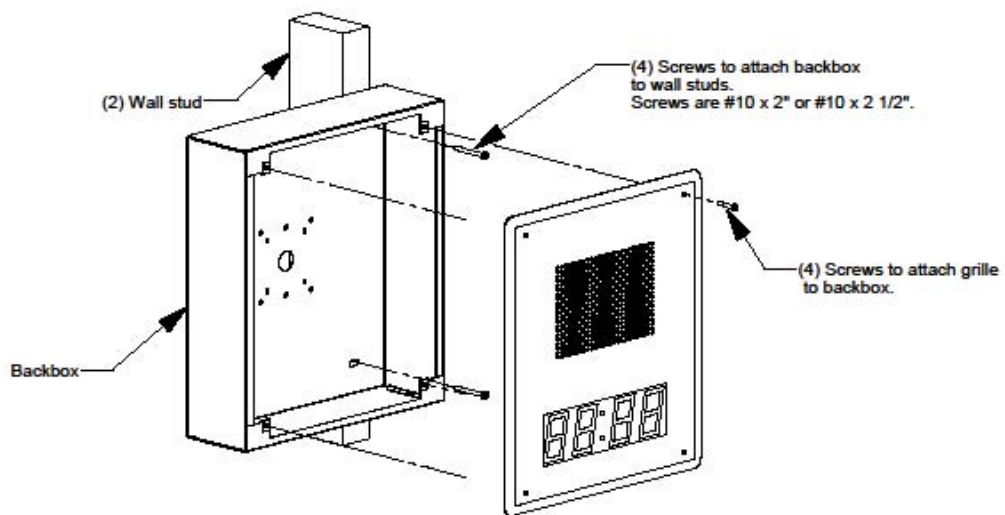

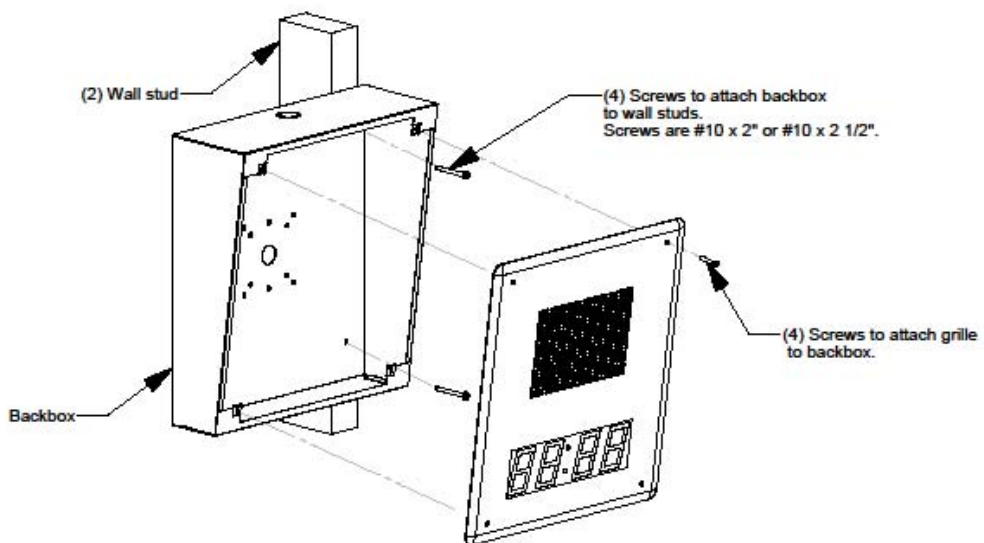
